Celebrating REtail, Accommodations, Tourism, and Entertainment by Building Rural Innovations and Developing Growth Economies

Regional Application

About the CREATE BRIDGES Initiative: While manufacturing and professional services are often the focus of economic development, businesses focused on retail, accommodations, tourism and entertainment are important to the viability of rural communities and regions. These industries provide needed goods, services and amenities to local residents and visitors and enhance quality of life. They are a major source of jobs and tax revenue in rural communities. They often provide the first work experience for residents who move up the career path within these businesses or go on to work in other sectors.

Currently, planning and training focused on these sectors is often neglected or underemphasized despite a need to strengthen it. As a result, small and large businesses alike face high worker turnover rates and a dwindling pool of mid/upper management workers. The CREATE BRIDGES initiative was launched to develop and test a process to fill this void, particularly in rural areas. The process is designed to raise awareness of the role these important businesses play in the local economy, determine challenges and barriers negatively impacting those businesses, and develop and implement strategies to strengthen the retail, accommodations, tourism, and entertainment sectors within a region.

Focus: In the CREATE BRIDGES process, we will focus on those businesses related to *retail*, *accommodations*, *tourism*, *and entertainment*. Throughout this document, "CREATE businesses" refer to these four types of businesses.

Purpose: The purpose of the CREATE BRIDGES Initiative is to build the capacity of rural regions to strengthen the CREATE sectors.

Background: The CREATE BRIDGES Initiative was developed through a partnership among the Southern Rural Development Center (SRDC), University of Kentucky's Community & Economic Development Initiative of Kentucky (CEDIK), University of Arkansas Cooperative Extension Service's Community, Professional and Economic Development (UACES-CPED), Oklahoma State University Cooperative Extension Service, the University of Illinois Cooperative Extension Service, New Mexico State University Cooperative Extension Service, and North Carolina State University.

Eligible States/Regions: Regions located in [insert state or region] are invited to apply for the CREATE BRIDGES Initiative. One two-to-five county region will be selected to participate.

To qualify for this program, a region must be classified as rural and economically distressed as defined below:

• **Definition of Rural Region:** The region must encompass two to five contiguous counties (with some exceptions for Tribal areas) and the total population and/or geographic area of the region must meet the following requirements: at least 51% rural in nature. Regions may cross state boundaries as long as the counties that make up that multi-state region meet the rural requirement.

For purposes of this application, rural refers to counties that are classified as non-urban. [Check the U.S. Census Bureau for current definitions of urban and non-urban. Include a link for reference.]

• **Definition of Economically Distressed:** A region is considered economically distressed if it meets one of the following requirements: (1) The poverty rate for the region is at or above the state average; OR (2) The region has high unemployment or low labor force participation rates relative to the state average. [Check the U.S. Census Bureau for the current definition of "economically distressed," and include a link for reference.]

What will happen if my region is selected to participate in the CREATE BRIDGES Initiative? Major steps in this process will include:

- Form a Regional Steering Committee that is diverse and representative of the population and that represents each of the CREATE BRIDGES targeted business sectors, state/local workforce agencies, chambers of commerce, economic development, education, local government, and others as appropriate. Each Regional Steering Committee should have representation from at least five relevant sectors (such as education, business, workforce development, government, tourism, non-profit) with a minimum of five active partners per participating county and demographic representation appropriate for that region.
- Conduct an Inventory of CREATE businesses, existing training programs and workforce development
 resources, and service providers in your region that can support these businesses as well as resources
 that can support the project as a whole.
- Host a CREATE Forum as an opportunity for additional stakeholders and community members to convene, learn about CREATE BRIDGES, and provide input through guided discussion.
- Implement a Business Retention and Expansion Program to survey local CREATE businesses, analyze the strengths and weaknesses of the business environment, and set priorities for action to help these businesses thrive and grow.
- Implement an Employee Perspectives survey to engage employees about their work experience and to determine challenges and barriers to employees in these sectors.
- Host a CREATE Academy to increase understanding of the interdependence of CREATE BRIDGES sectors and the rest of the economy, begin exploring workforce challenges, and build support for the initiative.
- Develop and implement new strategies and actions to strengthen the CREATE business sector, including its workforce, in your region.

How to Apply: Complete the attached Application Form and submit it by [insert time] local time on [date]. You will receive an acknowledgement of your application within two business days. We urge all applicants to contact us immediately if they have not received an acknowledgement within this time period. As part of the application you will be asked to demonstrate:

Description of the region: Why the proposed counties make sense as a region, providing a description
of the driving forces that draw them together to focus on the CREATE business sectors.

- Evidence that the rural and economically distressed criteria are met: How the region qualifies as rural and economically distressed based on the definitions above and data from the region.
- Evidence of working together: Previous experience and/or other programs the proposed counties have worked on together or completed as a region, or if the region has not worked together previously, the region's current capacity to work together.
- Stakeholder buy-in: Letters of commitment from Regional Steering Committee members indicating a
 willingness to drive the process and letters of support from key stakeholders who will support the
 CREATE BRIDGES initiative. Key stakeholders include, but are not limited to, regional/local workforce
 agencies, chambers of commerce, economic development, education, and local government. These
 letters should include an explanation of how one or more members of the proposed Regional Steering
 Committee have been involved in collaborative regional efforts.
- Regions need to identify 2 people who are willing to serve as the primary contact for the duration of the project (Part 1.C of the application). These individual(s) will assist the project coordinator in leading and convening the Regional Steering Committee. It is recommended that the two co-chairs represent different organizations or entities, providing more stability to the Regional Steering Committee's leadership if there is a change in one organization's structure or leadership.
- Evidence that CREATE businesses are a workforce or economic development priority for the region

Selection Process: All applications will be carefully reviewed. The project coordinator may contact applicants in order to conduct site visits and a tour with representatives of your group. Once the evaluation is complete and a final decision, the selected region will be notified. An announcement will be made by [Date].

How Proposals Will Be Scored: All proposals will be scored on a **100 points basis**. The following details the maximum amount of points associated with each component of the CREATE BRIDGES application.

Proposals from regions that do not meet the definition for Rural and Economically Distressed will not be considered.

Please note that incomplete proposals will not be scored.
